4. Details of our assessment

5/06/25 - Site visit

Site inspection of Forest Holidays Garwnant Site Hydropower impoundment was carried

out by Environment Officer Callum Murray on the 25th of June 2025. The weather at the time of visit was ~25°C and clear sky.

The inland watercourse (Garwnant Fawr), specifically the point of impoundment at NGR SN 99832 13173 was assessed for compliance with the permit. All measurements of the intake weir and penstock pipe recorded during the visit were compared to the technical drawings and measurements listed within the permit, and no discrepancies were found.
