4. Details of our assessment

Due to an error this CAR was not received by DCWW. Action deadlines have therefore been extended, and the CAR has been reissued.

Compliance inspection undertaken by Environment Officers Harry Warburton, Hannah Jenkins and Alexander Grainger. Accompanied by Dwr Cymru operators to inspect permit AN0243201 for Penarth Marina pumping station. Weather at the time was dry.

Penarth Marina pumping station pumps up Paget Road and joins the line with Penarth head pumping station. Penarth Marina pumping station has online storm storage capacity of its own wet well, as well as the sewer network around the area. There is a static overflow screen located to the east of the pumping station by the Old Custom House restaurant. Any excess storm flow that cannot be passed forward by the pumping station, would pass through and join the storm overflow line and outfall that is shared with Penarth Head pumping stations storm overflow outfall at ST 19303 72152. The screen appeared in good clean order.



The sites maintenance log book was inspected and the site seems to be visited every 1-2 months. The site has frequent comms failure entries. This appears to be a historic issue since the sites return data for 2022 was 22.49% and 56.36% for 2023. The data for 2024 has not yet been processed.

As per permit condition 3.1.4 *"The operator shall take appropriate measures to ensure that the event recorder remains fully operational at all times within the reference period specified in table S3.1. Any failures shall be remedied as soon as reasonably practicable."*

Action:

- Investigate the reasoning for the frequent comms failures and provide a plan with timelines as to how the comms issues will be addressed for the site.
