Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Due to the low flows currently being observed in watercourses in the North East area of Wales, a check of irrigation licences and licences with flow conditions is being carried out.

The file for licence 24/67/7/0135 shows that a transfer request was submitted in 2020 by an

agent for the Plas Power Estate. For a transfer to take place, a variation was needed to remove the reach marked 'G' to 'C' as there is no longer access to this as the land has been developed and now contains a housing estate. The variation was not carried out, so no transfer occurred.

A call was made on the 19th August 2025 to the licence holder to determine the current use of the licence. This found that the licence hasn't been used for a number of years, and that the charge for the licence from NRW is being paid for by the Plas Power Estate. The licence holder was made aware of their liability if a non-compliance were to occur by a third party using the licence. The licence holder was advised that the licence should be transferred to the Estate if it is to be used by them, or surrendered if it is no longer required.

The licence holder was welcoming of a visit by NRW to look at the area covered by the licence, but this isn't currently required as there isn't a pump in place. Should a decision be made to use the licence, as covered by condition 8 of the licence, the pump and location must be agreed before an abstraction takes place.

The licence holder will discuss the transfer of the licence with the Estate.

Can you please provide an update on the intentions with the licence by the 1st Oct 2025.
