4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced following an assessment of one section of the site's Environmental Management System (EMS).

The assessment was partial in scope - focusing on how the Operator manages compliance with changes to statutory environmental obligations so to identify and minimise the risks of pollution.

The focus was chosen in anticipation of the formation of the UK Best Available Techniques (UK BAT) for the Surface Treatment of Metals and Plastics Sector (STM), for which the operator has been determined to possibly be in scope of.

Permit condition 1.1.1 is partially reproduced below:

The operator shall manage and operate the activities:

(a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, nonconformances, [closure] (This does not apply to mobile plant, stand-alone water discharge activities or stand-alone groundwater activities.) and those drawn to the attention of the operator as a result of complaints; and

(b) using sufficient competent persons and resources.

Sector and technical guidance set the standards for EMS.

As part of this assessment the following document which forms an addendum of the EMS , was assessed:

- Change Management UK-QUAL-02-004, Rev 5

Systems and processes associated with the above document were suitably demonstrated on site.

The partial assessment indicates that the operator has sufficient detail in their EMS to manage compliance with changes to statutory environmental obligations.

The EMS is therefore determined to be compliant with permit condition 1.1.1 in respect of how the Operator manages compliance with changes to statutory environmental obligations.
