4. Details of our assessment

Site Report

A compliance visit for the permit was undertaken on 11/07/2025. Two Natural Resources Wales (NRW) Environment Officers and the president of the club were present. The weather was warm and dry.

The site appeared in good working order.

The intake is upstream of the fish farm, water is piped down to the site which feeds the holding tanks. V notch readings are taken and an equation used to calculate flow leaving site.

Breach of permit:

Point 7 – The volume of effluent discharged to the river shall not exceed 1972.5 cubic meters in any period of 24 hours.

The returned data shows for the year 2024 that on occasion, the daily discharge limit is exceeded.

Actions:

-Condition 9 of the permit states '*The effluent discharged shall not contain any prophylactic or disease treatment materials without the prior written agreement of the authority.*'

As Formalin is occasionally used at the site a written management system should be put in place to ensure that it does not pose a risk to the receiving waters. This written management plan should identify and minimise risks of pollution, including those arising from operations, maintenance, accidents, incidents and non-conformities. In preparing the management system, the operator should consider how they will use the chemical at the farm, including the method of disposal of the contents of any tank used in treatment demonstrating that it will not have any effect on the environment. Due by the **01/10/2025**

- Condition 7 Please ensure that the consented discharge limit is not exceeded or a licence variation would be required.
