## 4. Details of our assessment

The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer to comment upon the Q2 Monitoring Returns.

### **Q2 Monitoring Returns.**

Q2 2025 (April - June) monitoring results were submitted to NRW on 08/08/25 in accordance with Condition 4.2.3.

Emissions to Water - Emission Point W1.

Emissions to water for Q2 were tested on 15/04/2025, 16/05/2025 and 11/06/2025. All parameters were within the emission limit values (ELVs) defined in the Permit (Table S3.2).

The testing on 16/05/25 did indicate a rise in BOD to 21mg/l (Q2 BOD figures for April and June were 6mg/l and 2mg/l respectively), but still comfortably within limits.
