The returns for reporting of sampling and analysis of emissions to water (other than sewer) to discharge point W5 for Q2 (1 April - 30 June 2025) were submitted to NRW on 20 August 2025.

Emissions to sewer - *Sewer 1 / 09/07/2025*

The returns for reporting of sampling and analysis of emissions to sewer to discharge point S1 for Q2 2025 were submitted to NRW on 20 August 2025.
