4. Details of our assessment

Routine inspection of Asset. The weather conditions were dry and sunny at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BG0010201) for the site is for the discharge of secondary treated sewage effluent and Discharge of Storm Sewage to the Afon Teifi.

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers checked the discharge point to the Afon Teifi later in the day, there did not appear to be any evidence of an impact to the receiving watercourse.

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

Effluent enters the site at the inlet, there is a screw press screen at on the inlet, the screenings automatically go into a skip on site. There is no storm overflow present at the site, storm sewage is discharged from the Wilkes Head Pumping station.

The works consists of 3 primary settlement tanks, 2 large sets of filter beds, and 2 large final settlement tanks. The arms on the filter bed were moving freely and there did not appear to be any issues with pooling and excessive vegetation on the media in the beds.

Permit breach

Condition 2.2.1 The discharge activity shall take place at the discharge point marked on the site plan at schedule 7 to this permit, and as listed in table S3.2.

There was sewage leaking out of the primary tank, with evidence of effluent pooling at the on the ground around the final settlement tanks. Due to the leak originating from an overgrown area officers were unable to identify the source of the leak. It was discussed at the time of the inspection that the source of this leak needs investigation and repairing prevent further discharges to the ground.

Due to an IT issue this CAR was not received by DCWW, deadlines have therefore been extended and the CAR has been reissued.
