4. Details of our assessment

Routine inspection of Asset. The weather conditions were dry and sunny at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BN0267201) for the site is for the discharge of biologically treated sewage effluent and to the Afon y Cwm.

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers checked the discharge point to the Afon y Cwm and there did not

appear to be any evidence of an impact to the receiving watercourse.

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

The works consists of a small Rotating Biological contactor system, both ends of the system where opened up and inspected, the filter was rotating freely and looks to be in good working order. The final effluent from the site looked clear.

There is no screening requirements or any storm overflows present at the site.

The entire system is emptied via tanker every 12 weeks, or sooner if the ammonia levels creep up in the routine samples.

Due to an IT Issuer this CAR was not received by DCWW. CAR has been reissued.
