The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer to comment upon the 6 monthly Monitoring Returns.

Monitoring Returns. 2025 (Jan - July) monitoring results were submitted to NRW on 01/07/25 in accordance with Condition 4.2.3.

Emissions to Sewer - Emission Point S1.

Emissions to sewer were tested on 13/06/2025. All parameters were within the emission limit values (ELVs) defined in the Permit (Table S3.1) as follows:

Lead - 0.433mg/l vs permitted ELV of 0.5mg/l.

Zinc - 0.014mg/l vs permitted ELV of 2mg/l
