## 4. Details of our assessment

The impoundment licence to abstract water from inland water (stream) known as Afon Lliw near Dolhendre Caravan Park, Llanuwchllyn, Bala, Gwynedd was inspected by Laura Jones from the Conwy Environment Management team and Sioned Jones from the Dwyfor and Meirionydd Environment Management team on the 31<sup>st</sup> July 2025.

### 1. Name of Inland Water To Be Impounded

Inland water (stream) known as Afon Lliw near Dolhendre Caravan Park, Llanuwchllyn, Bala, Gwynedd

### 3. Manner and Extent of Impoundment

Intake works consisting of concrete weir with a Coanda screen of 2 millimetre bar spacing, with an internal diameter not exceeding 1000 millimetres, Hands off Flow (HOF) notch, adjustable plate, fish way with ponds, eel passage in accordance with the specifications and drawing.

No issues were identified

### 4. Further Conditions

1. For the purpose of this licence, references to 'intake works' shall mean all works consisting of a concrete weir with a Coanda screen of 2 millimetre bar spacing, pipe with internal diameter of 1000 millimetres, Hands of Flow (HOF) notch, adjustable plate, fish way with ponds and eel passage.

4.5 The Licence Holder shall construct, operate and maintain the intake works in accordance with the specifications and drawings referred to in condition 3.1 of the licence and keep them free from leakage and obstruction at all times.
