### 4. Details of our assessment

Compliance inspection of permit AN0299001 at Rhoose Point SPS. Undertaken by Environment officer Harry Warburton. Accompanied by DCWW performance manager, AGA and BGA pollution techs. Weather at the time was dry.

Rhoose Point SPS was adopted by DCWW from the building development shortly after 2000 when the permit was issued. The SPS is consented for discharge only during an emergency. The outfall is to the old quarry lake next to the site. The outfall was inspected

and there is no signs of any discharges in recent times. There is a small mesh screen in place at the overflow pipe within the wet well. The sites log book was also checked with no records of issue.
