### 4. Details of our assessment

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.

On the 12/08/2025 a Natural Resources Wales (NRW) officer carried out a routine unannounced inspection of the hydroelectric power (HEP) scheme on Nant Llwynon.

The licence holder was spoken with before the officer carried out the inspection unaccompanied. The visit was undertaken to assess compliance of the HEP scheme in relation the abstraction licence WA/054/0001/108.

The weather was hot and dry, and there had been very little rain in 4 months preceding the inspection.

The by-pass flow mechanism appeared to be working correctly. The intake screen appeared to be as required by the licence but was mainly obscured with algal growth and could benefit from cleaning before we enter the autumn weather to ensure that the system makes efficient use of the natural resource.

There were plastic brush bristles lodged in some debris on the intake screen, you should replace your brush so that it does not release litter into the watercourse.

It was not possible to access the discharge point sufficiently to determine if there is a 10mm bar spacing screen present as specified by condition 9.1. As you are currently not abstracting there is no impact, however if you were to begin abstracting without the screen present this would be considered a permit breach. Please ensure your discharge screen is present and correct.
