4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine inspection at Bryn Posteg gas plant.

The Site Manager and Environmental Technician accompanied NRW officers during the inspection.

The Site Manager confirmed that the landfill gas engine had recently been serviced and was operational with no known issues.

Officers did not detect any landfill gas odours in the compound.

Within the gas engine compound, officers observed an IBC containing potentially polluting liquid that was stored without appropriate secondary containment. NRW considers this a breach of permit condition 3.2.3 and a non-compliance score has been applied (IR3B-Emissions of substances not controlled by emission limits-C3).

Action 1: Ensure IBCs/ any other containers containing potentially polluting substances stored within the gas compound are provided with adequate secondary containment e.g. bunding, drip trays. Provide photographs to NRW by the specified date to show this has been completed.
