1.7 Ongoing Engineering of Relevant structures

This conditions requires the production of a detailed design and construction CQA plan. This plan was duly submitted to NRW in April 2024 in appropriate time for assessment and approval before the commencement of works. The plan was approved by NRW in April.

1.8 Regulatory Standards for the Construction of Caps, Waste Slopes, Surface Water Drainage Layers and Cover Soils

This condition requires that the capping is constructed in accordance with the submitted design and standards are referenced throughout to the CQA plan submitted as part of the engineering and design requirements as laid out in the permit. All aspects of the design and the build are subject to the oversight of a CQA engineer and the Engineering Team of the on site contractors. All aspects of this process were in compliance with permit/design/CQA requirements on the day of inspection.

2.2.6 Odour

There was limited odour detected on site and during a follow up odour inspection in the nearby village of Llysfaen, there was no odour detected. The site gas contractor is managing the gas system sympathetically to the needs of the construction team during this phase of final capping. This limits fugitive and point source emissions during the process.

2.9 Noise and Vibration

Although additional heavy machinery has been operating on site to enable final capping works to be undertaken, all precautions to limit noise have been taken. Including, working hours and strict idling limitations. During the inspection of the surrounding area and the village of Llysfaen there was no evidence of any noise from landfill operations during the time of the inspection.
