4. Details of our assessment

I (Environment Officer Gavin Dodd) arrived at Wentwood Reservoir, Newport on Monday 13th January 2025 at 10:00 to conduct an inspection regarding a licence to abstract water. (Permit Number 20/56/72/0018). Water Resources Technician Kevin Betts was also in attendance.

The sources of supply were Wentwood Reservoir and the Nantypriidd and Castroggy Brook. The places of abstraction were a draw-off tower for Wentwood Reservoir and a

stream intake for the Nantypriidd and the Castroggy Brook.

The means of measuring the quantity of water abstracted is specified in the permit as a meter for the draw-off tower and by an autographic rainfall recorder for the Nantypriidd and Castroggy Brook. The means of measuring the amount of water abstracted from these sources is through an electronic meter in the Llanvaches. It was not possible to read this meter on site due to access.

The abstraction from the Nantypriidd and Castroggy were not being used on the occasion of the visit. These both fed into the reservoir via a stream intake and only a small trickle of water was feeding into it from this source. The abstraction from the Nantypriidd was not currently being used but the capability to do so remained, but the abstraction from the Castroggy is not in a usable condition due to infrastructure and overgrowth.

Following the visit, information was submitted by South West Area Water Resources Manager Tom Elmitt that the main from Wentwood reservoir has been cut and capped. At present, DCWW are unable to abstract water from the reservoir
