3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales, accompanied by site employee.

General Management W1A - Category 3

Under condition 1.1.1 (a) of the environmental permit, the site is required to operate in a manner described within the management system (EMS). During the inspection it was noted that waste oils were stored within a battery box adjacent to the double bunded tank, with evidence of possible spillage in adjacent drain. Furthermore, the box was open to the element that would allow the ingress of rainfall as seen in the image below.



Further to the storage of oils, it was noted that some wastes were stored on an area of hard standing, adjacent to the employee car parking area. At the time of the inspection, these wastes included a skip of cardboard, the gas bottle storage for the site and the locked asbestos container.



The EMS that was submitted to NRW (Revision 2, dated October 2023) states that all wastes are to be stored on an impermeable surface with sealed drainage.

This has been scored as a **category 3 breach** of permit **condition 1.1.1 (a)** for failure to store waste in a manner as described within the EMS.

Action - Ensure that all wastes are stored appropriately, in line with the EMS and the conditions of the permit.

Drainage channels show signs of lack of maintenance with a significant section showing vegetation growth and build up of material which will reduce its effectiveness.

Action - Ensure that drainage channels are kept clear and maintained.



Staff on site were able to provide a copy of the EMS and the permit on request as required under **condition 1.1.3** of the permit.

Waste Operations - W2C, W2D and W2E - Category 3

Wastes accepted onto site were compliant with the wastes listed in schedule 2 of the environmental permit. However, under **condition 2.2.1 (a)** and **Schedule 2** and the limits of activities. *All wastes must be stored on an impermeable surface with sealed drainage .*

This has been scored as a **category 3 breach** of **condition 2.2.1 (a)** with the root cause identified as a failure to follow the operations EMS as required under **condition 1.1.1 (a)**.

Action - Ensure that wastes are stored in accordance with the permit condition.

Waste - Emissions and Monitoring W3C, W3D, W3F

No issues were identified in relation to emissions during the time of the inspection under conditions 3.4.1 (Odour), 3.5.1 (Noise) and 3.6.1 (Pests)
