4. Details of our assessment

Lamphey WWTW was visited on 13 February 2025

The treatment works had a substantial upgrade approximately nine years ago and appears in good working order.

According to the Permit, the Flow Passed Forward rate is 4.9 litres per second, 1.3 litres per second was observed during the visit.

Please advise if the FPF rate of 4.9 can be achieved.

Based on current data, Lamphey WwTW is capable of achieving its permitted flow rate of 4.9l/s, with a recorded year-to-date maximum of 6.2 l/s. However, it's important to note that we are not currently Q95 compliant year-to-date. While the treatment works can achieve the 4.9 l/s rate, achieving consistent compliance will depend on sustained flow performance and operational conditions.
