4. Details of our assessment

At 15:00 hours on Wednesday 13th August 2025, NRW Waste Regulation Officer, Joe Weatherley and Hazardous Waste Regulation Officer Molly Callow attended ASH Bretton Recycling Centre. The purpose of the visit was to investigate reports of fugitive dust emissions coming from the site. Upon arrival the officers were greeted by the site manager for the day who provided information and accompanied the officers during the inspection.

During the time of the visit the site was fully operational and busy, the weather conditions sunny, hot and very dry. The officers could see that dust was being produced at the site and this was becoming airborne. This was particularly the case towards the southern boundary of the site. An operative was engaged in sweeping the ground in this area with an item of plant equipment designed for this purpose. This activity itself was producing visible airborne dust. Airborne dust could also be seen around the activities at the waste containment bays.

The manager pointed out that the ground had been dampened with water that had very quickly dried up in the heat. The water spray curtains were operating where necessary.

Action: Ensure activities are managed and operated in accordance with the site Environmental Management System and Dust Management Plan. Ensure dust prevention measures are sufficient and are used frequently enough to deal with any potential increase in the volume of airborne dust during prolonged dry conditions.

Condition 1.1.1 (a) of the site permit states *"The operator shall manage and operate the activities: in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints "*

Although the officers saw no evidence of dust leaving the site during the visit, they believe this may be happening. Please ensure that dust control measures at the site, the site Dust Management Plan is enacted during periods of hot, dry weather to ensure that dust does not escape the site and impact on neighbouring businesses.

If it is perceived site operations will be causing excessive amounts of dust to leave the site and the Dust Management Plan would not be sufficient to keep the dust levels to a minimum then site operations must cease until this has been addressed and the Dust Management Plan reviewed.
