4. Details of our assessment

On Thursday 15th August, Waste Regulation officer Joe Weatherley and Senior Waste Regulation Officer Steve White visited Bryn Lane Civic Amenity Site and carried out an unannounced site inspection. The officers were accompanied by the site manager and his colleague throughout the visit. All waste types requiring storage in containers were adequately contained and the containers were of an adequate size with no signs of overspill of waste into the open. All waste types were correctly segregated.

The skips provided for the incoming waste streams were clearly signed and segregated. Several bicycles had been deposited in the Large Domestic Appliances skip. The site manager pointed this out and assured the officers that this sometimes happens but site operatives check regularly for this and correct it.

During the visit the officers saw an operative removing general waste in black refuse bags from the general waste skip. The operative sorted through the waste checking for recyclable items and removed them accordingly.

The site perimeter fence was intact and the manager stated there had been no security issues to report.

Generally the site is functioning well and is kept clean and tidy.
