4. Details of our assessment

On Monday the 11th of August 2025 Ian Thomas , Waste Regulation Officer, carried out an unannounced routine site inspection at Bagillt Car Spares. The weather was sunny and dry.

During the inspection the officer was accompanied by the owners, Michael Waugh and Peter Duffy.

On the last visit it was noted that the operations on site had been improved. The site is now running well with all engines and gearboxes being removed and there are large skips outside the depollution area where engines are loaded into one, and gearboxes into the other. The skips are covered at the end of each day. These are collected by Lelo and removed from site. The car shells are then stored in the top area of the site and sent to Naughtons. There were a few engines and parts on sealed ground but Michael explained these were to be moved into the skips for storage.



There was an area at the entrance to the depollution area where a small amount of oil was apparent on the ground, this is contained to the area and was due to the engines being loaded into the skips. Waste batteries are stored in a sealed and weatherproof container and undercover.

A review of the waste return submissions has been completed and quarter 2 was outstanding. Peter checked and the returns were to be uploaded immediately. Waste transport notes are recorded and stored as required. No other issues were apparent.
