## 4. Details of our assessment

### **SITE INSPECTION - GENERAL MANAGEMENT, PEST CONTROL AND FEEDSTOCK CONTAINMENT**

**29 August 2025**

An un-announced site inspection was undertaken on the above date at approximately 10:30hrs. to ascertain the efficacy of recent pest (bird) control measures on site. It was found that all of the agreed protocols are now in place.

The EMS covers the management and cleaning protocols for feedstock on site and this must be followed as a minimum to maintain control and avoid any potential future incidents.

The agreed protocols, which should now form part of the management system are now being followed and the site is fully compliant with these aspects of the permit.

Following from the previous unannounced visit on the 11<sup>th</sup> August, standards have been maintained, ensuring bird numbers are very low or absent reducing the risk to RAF Mona.
