4. Details of our assessment

This Compliance Assessment Report (CAR) relates to Brynymor Road Combined Sewer Overflow (CSO) which is an overflow located in a busy road where traffic lights would be required to carry out an inspection.

In place of a site inspection I have reviewed any information we have on the CSO including the Event Duration Monitoring (EDM) 2024 data submitted to us and any completed actions from previous CARs.

The permit for Brynymor CSO allows the discharge of storm sewage as defined by the permit conditions via an outfall to Swansea Beach. The outfall is known as the Patti Pavilion outfall.

The overflow setting is 12.5 l/s. The recorded number of spills indicates that the flow passed forward is being achieved.

There are no screens fitted. When this storm overflow is classified under Guidance Note 066 Classifying Storm Overflow Performance it is likely to be classified as Substandard due to the lack of a 6 mm screen.

The discharge from this CSO is not subject to a spill trigger limit of 5 during the bathing water. The submitted EDM for 2024 data recorded no spills during the whole of 2024. However, only 44.47% of data was recorded in 2024. Normally the EDM at Brynymor CSO reports over 99% of the time and records 1-3 spills per year. Data quality will be assessed when the 2025 EDM return is submitted.
