4. Details of our assessment

Site Report

On Tuesday 26th August I visited Hospital Farm, Penpedairheol, Hengoed, Caerphilly CF82 8DG to carry out a permit inspection on their domestic septic tank. Permit Number AN0414901 . I arrived on site at 11.50. The weather conditions were dry, warm and sunny. My Site inspection commenced at 11.55.

Observations

I proceeded to identify the location septic tank. Please see Fig 1 below.

I checked the discharge to ground location at national grid reference ST 13857 98255. I can confirm this to be accurate as stipulated by the permit. Please see Fig 2 below.

I proceeded to check the septic tank chamber. Please see Fig 3 below.

A visual inspection of the septic tank chamber was carried out. No issues found. No odours present. No issues concerning discharge method or receiving soakaway.

Mr Thomas advised the septic tank is still being desludged approximately every 12 months.
