### 4. Details of our assessment

This compliance for is the result of a routine inspection of the DCWW asset Llantwit Major SPS, Permit number BP0270901 on 20/08/2025 by NRW officers Martyn Davies and Alexander Grainger.

Arrived on site at 12:30pm with DCWW. NRW were unable to get access within the SPS building itself due to being a different area covered by the DCWW pollution technician, therefore, the screens for this asset were unable to be inspected. Due to this, NRW request pictures of the screens at this asset for review as well as the maintenance frequency of these screens be provided.

NRW checked the DCWW storm overflow map which indicates that this asset last spilled into the Col-Huw watercourse on 15/04/2025 for 15 minutes.

Went down to the watercourse which looked to be in good condition with no signs of pollution present at the time of the visit. The outfall was unable to be seen due to a lot of overgrown vegetation.
