4. Details of our assessment

Compliance inspection of abstraction licence 21-58-11-0002 at Biglis Wells, conducted by Environment Officer Harry Warburton and Senior Environment Officer Hannah Jenkins. Accompanied by DCWW operators.

Biglis Wells consists of two boreholes to abstract groundwater to supply industry in Barry. Prior to inspection the abstraction returns for 2023 and 2024 were inspected against their abstraction quantities and there were no breaches of over abstraction.

Biglis Wells consists of 4 pumps to supply one industrial customer, and 3 pumps to supply another. Both with metred telemetry to show pumped volumes. It was observed in the pump area of the borehole that there was a black pipe discharging to the covers, this water would fall back into the borehole, however the excess water may cause corrosion to some infrastructure. DCWW mentioned this was being looked in to and soon to be addressed.



DCWW monitor the volumes pumped to the customers, and it was queried whether the industrial customer also has a receiving water monitor, so that the volumes can be compared and checked for any signs of leaks. It was mentioned that there had recently been some pipe leak repairs along this line.

Action:

- Provide information on the location(s) of any recent leak repairs between Biglis Wells and the industrial customers.
