4. Details of our assessment

Compliance of Control of Pollution (Amendment) Act 1989

On Friday 8th August 2025 Andy Prestt, Carriers and Brokers Officer visited M&E Bin Hire Ltd – permit reference SP3495FG checking waste transfer notes, customer waste carrier licenses and site duty of care compliance processes.

You demonstrated that you have records of waste carrier licenses for customers that use the site to weigh in scrap metal. It was discussed the challenges you have in getting some waste carriers to register as waste carriers and the detriment this could have on your business / staff safety if this is over enforced.

Whilst at the site additional checks were made on vehicles tipping scrap metal. These businesses were registered as waste carriers, except one who's waste carriers license had recently expired.

If a business is not registered as a licensed waste carrier and refuses to do so Andrew.prestt@naturalresourceswales.gov.uk is to be contacted to provide support and get the business to sign up as a waste carrier.
