4. Details of our assessment

Impoundment Licence WA/065/0001/015/V001

A visit was made to the Teiliau Bach Hydro Ltd site on the Afon Teigl on 06/06/2025. The intake works were built at the correct location and appear to match the drawings in the

licence. This includes the weir, Coanda screen, sump, pipe, eel pass, fish pass, and plunge pool. However, this will need to be confirmed by measurement. The intake works were in good condition and free from blockage or leaks.

One tile on the eel pass had fallen off and needs to be replaced to ensure the structure works as intended.

ACTIONS: Replace the missing eel pass tile to maintain the effectiveness of the fish passage, in line with Condition 4.1 which defines the required intake works.

Once the action is complete, a photo showing the repaired eel pass tile should be taken for record. This image should be sent via email to sioned.w.jones@cyfoethnaturiolcymru.gov.uk by 17/10/2025.
