Q2 2025 Monitoring returns

The Q2 2025 monitoring returns were received on time and have been reviewed and accepted.

CAR NRW0048645 Actions Outstanding Actions

Action 1: To gain a better understanding of the current monitoring regime, NRW requests an up-to-date site map showing the locations of all active monitoring points. Due: 1 st of September 2025.

Action complete.

The current round of monitoring shows that LF10M exhibited a rise in copper levels exceeding the normal variance. Further investigation revealed elevated concentrations of other metals as well. This borehole is scheduled for resampling in Q2 2025.

Action 2: Please share the results of this resampling with NRW at your earliest convenience.

LF10M was resampled on 7th May and the Cu result was 51.9, but when the sampling was attempted on 9th July we were unable to draw the sample. Dow believe that the borehole may be damaged due to them being narrow. Dow will continue to try monitoring this borehole. Dow have informed NRW that they still have the and see how shallow and deep ones for this location.

LF10M was resampled on 7th May, with a Copper (Cu) result of 51.9. A further sampling attempt was made on 9th July, but Dow were unable to obtain a sample. Dow believe the borehole may be damaged, potentially due to its narrow construction. They are continuing efforts to monitor this borehole. Dow have also informed NRW that they still retain the shallow and deep boreholes for this location.

This action is considered complete.
