- breach any requirements relating to [Environmental Impact Assessment \(EIA\) Regulations \(2002\)](#)
- breach any other directly applicable legislation.

If you fail to comply with these requirements you may be committing an offence and enforcement action may be taken against you. Failure to meet any of these Cross Compliance standards could result in a financial penalty being imposed by Welsh Government on the Direct Payments for the land deployed upon.
