Remove the large stones blocking the approach to the intake. Redistribute.

There had been a breach of condition 9.5 'Maintenance':

There was a build-up of boulders in the watercourse upstream of the intake which could have the effect of diverting water into the intake and away from the downstream watercourse. These needed to be redistributed.

In general, flow leading to the intake should be uniform and steady with no projections into the flow. This is in order to provide sufficient flow of water back into the downstream watercourse, and to ensure continuation of compliance.

Stones needed to be redistributed, away from the approach to the intake. According to our Geomorphologist, they need to be redistributed in the reach, up or downstream is acceptable. They should not be in one cluster together.

Action is completed.

Photos were emailed to me on the 15.7.2025 by Licence Holder. See photos attached 2435 and 2436 of the stones after being redistributed. Also photo 0775 before the stones were redistributed.
