4. Details of our assessment

On the 2nd September 2025 NRW officers visited Chatham lodges to carry out an inspection of the discharge permit for secondary treated sewage effluent.

The settlement tank which leads to an aerated package treatment plant was all operational during the inspection. The plant was fitted with an alarm which would notify the operator of any malfunctions. The treatment plant was regularly emptied by a contractor. Advice was provided regarding regular maintenance of the package treatment plant to ensure efficiency

of treatment. Advice was also provided regarding the use of harsh chemicals and its impact on the treatment process. The outfall was clear of any debris and was not discharging at the time of the inspection.

No non-compliances with the permit were observed.
