4. Details of our assessment

Routine inspection of Asset. The weather conditions were heavy showers at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BP0219002) for the site is for the discharge of biologically treated sewage effluent and Settled Storm sewage to

the Afon Myddyfi. The storm overflow was in operation at the time of the inspection.

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers checked the discharge point to the Afon Myddyfi and there did not appear to be any evidence of an impact to the receiving watercourse. The discharge outlet is angled upstream in the receiving watercourse, the flows were relatively high at the time of the inspection, but on low flows this could lead to the effluent pooling as the watercourse has created a gravel bar in front of the discharge point.

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

The works consists of an Aeration Channel, a small filter bed and a final settlement tank. The Aeration channel appeared to be in good working order, the filter bed was also in good working order with the arms moving freely and no evidence of pooling or excessive vegetation growth present. The final effluent from the site looked clear.

There is a bar screen on the inlet as well as a Copa Sac screen on the storm tank capturing solids before it is spilled to the environment. These screens are manually cleaned and changed when needed and the screenings go to a skip on site.

No Non-compliances were identified during the inspection.
