4. Details of our assessment

On the 2nd September 2025 an announced site inspection was undertaken at TS Reasons Limited, Alyn Works, Denbigh, Mold, Flintshire, CH7 1BT by NRW officers Phil Harper, Lead Specialist Industry & Waste Regulation and Stuart Ross, Senior Specialist Industry & Waste Regulation.

At the time of the inspection the site was operational.

General Site Condition.

Visually the site appeared to be clean and tidy. The operator discussed that works had been arranged to repair areas of the sites hardstanding and planned improvements to the wash down catchment pits near the tank farm.

The operator discussed the construction of a waste storage compound on waste ground at the lower end of the site. NRW advises that this is likely to require a normal variation to change the site boundary and to assess the level of containment against the site permit. The operator is advised to seek pre-application advice on this matter prior to submitting a permit variation application document.

No issues have been identified during the site inspection.
