4. Details of our assessment

Dragon Fruit Holdings Limited

PAN-005576

Dragon Fruit Holdings Limited were issued with a varied Bespoke permit on the 27th February 2023. The permit incorporates an additional Hargassner Magno-SR 1200 boiler which will be an additional 1.2 MWth input to the two WK RRK 1000 Binder boilers currently on site. The biomass boiler is virgin wood-fired and used to provide heating to the Edwards Business Park. Except for periods of downtime for maintenance the boiler will operate continuously (8760 hrs/yr) and have a 9m high stack (from ground level).

The permit requires Monitoring for NO_x, Dust and CO from emissions point A1, A2 and A3. The first monitoring has to be within four months of the permit issue date or the date when the combustion plant is first put into operation, whichever is later, then every 3 years thereafter. This new boiler was put into operation on the 25th of March 2023. NRW received the monitoring returns for emission point A3 from Dragon Fruit Holdings Limited on the 12th of July 2023. The results are well within the permitted emission limit values.
