Good afternoon Louise, I hope you are well.

We are looking to put in a storage bag on farm for winter storage of Volac-Sensient product. The current deployment 027540 expires 2/2/26 with all the spreading due to take place before the end of September 25, meaning we would not be able to deliver to the bag until the 3/2/26 at the earliest and therefore missing the winter period.

Would it be possible for us to bring forward the renewal date of this deployment once all spreading is complete, to allow us to deliver to the storage bag in the winter months, on the basis that the spreading would not take place until after 3/2 as would happen on a normal deployment renewal.
