4. Details of our assessment

On the 2nd September NRW officers inspected the permit. Within the shed and outside on the yard all run off was contained within the interceptor. The interceptor is on a rolling contract to be emptied twice a year. Waste Transfer Notes are retained by the operator.

Permit condition 3.3 specifies that permanent access must be provided to enable monitoring to be carried out at emission points specified in S3.1, S3.2 and S3.3. Access to the monitoring point was not possible during the inspection as the area was overgrown. Please ensure the emission point is accessible by **03/11/25**
