4. Details of our assessment

This report details the site visit made on the 2nd of September 2025 to A1 Skips, Newport, permit reference number EPR-FP3295FN. Natural Resources Wales (NRW) Officers Carla CURTIS and Mark O'GORMAN attended the A1 Skips permitted facility at Alexandra Docks, West Way Road, Newport, NP20 2UW for a routine unannounced site inspection. Officers arrived at 12.15 pm and met with the Site supervisor. The weather was cloudy and damp, it had been raining on and off all morning.

PERMIT BREACHES

No permit breaches have been identified during this site inspection.

GENERAL OBSERVATIONS

The site was operational at the time of the site inspection.

SITE INFRASTRUCTURE

General housekeeping on site was of a good standard with no loose debris visible. The impermeable pavement appeared in good condition (see photo1). There was some movement of waste at the time of the inspection ensuring the housekeeping in the area remained of a good standard. The height of waste stockpiles on site were within compliance of the sites Fire Prevention and Mitigation Plan (FPMP) and no issues were identified.

Drainage on site is via an interceptor and is cleaned periodically. There was no excessive noise along with no airborne dust present during the site inspection. There were also no offensive odours witnessed by NRW Officers on site and security was of no concern either.
