Enveo Aston is currently non-operational (although the permit was issued by NRW in December 2024) due to awaiting the relevant planning permission to begin operations, as such a desktop inspection was carried out concentrating on submission of waste returns to NRW.

Currently no waste returns have been submitted, even though the site is non-operational waste returns are still required to be submitted as 'null returns'
