4. Details of our assessment

JAB 93 Car Dismantlers Limited Site Visit, Bridgend (WP3498FW)– 16/09/2025

Waste Regulation Officer Gareth Morris accompanied by Waste Regulation Officer; Dan Hopkin and Enforcement Officer; Simon Powell visited Jab 93 Car Dismantlers Limited, Heol Ffaldau, Brackla Industrial Estate, Bridgend, CF31 2AJ on 16/09/2025 to conduct a routine site inspection and to assess compliance with environmental permit; WP3498FW).

The operator holds a: Tier Three (3) bespoke permit for metal recycling and end-of-life vehicle depollution and dismantling.

On arrival at site, we were met by the site director who kindly showed us around the site.

Weather on day of inspection, was clear, dry with little wind.

Areas assessed as compliant and other comments can be found below.

W1A- General Management

Permit Condition 2.3.1 states: *Any changes in the technically competent management of the site, the name any incoming person and evidence that such a person has the required technical competence, shall be submitted to the Agency in writing within 5 working days of the change of management.*

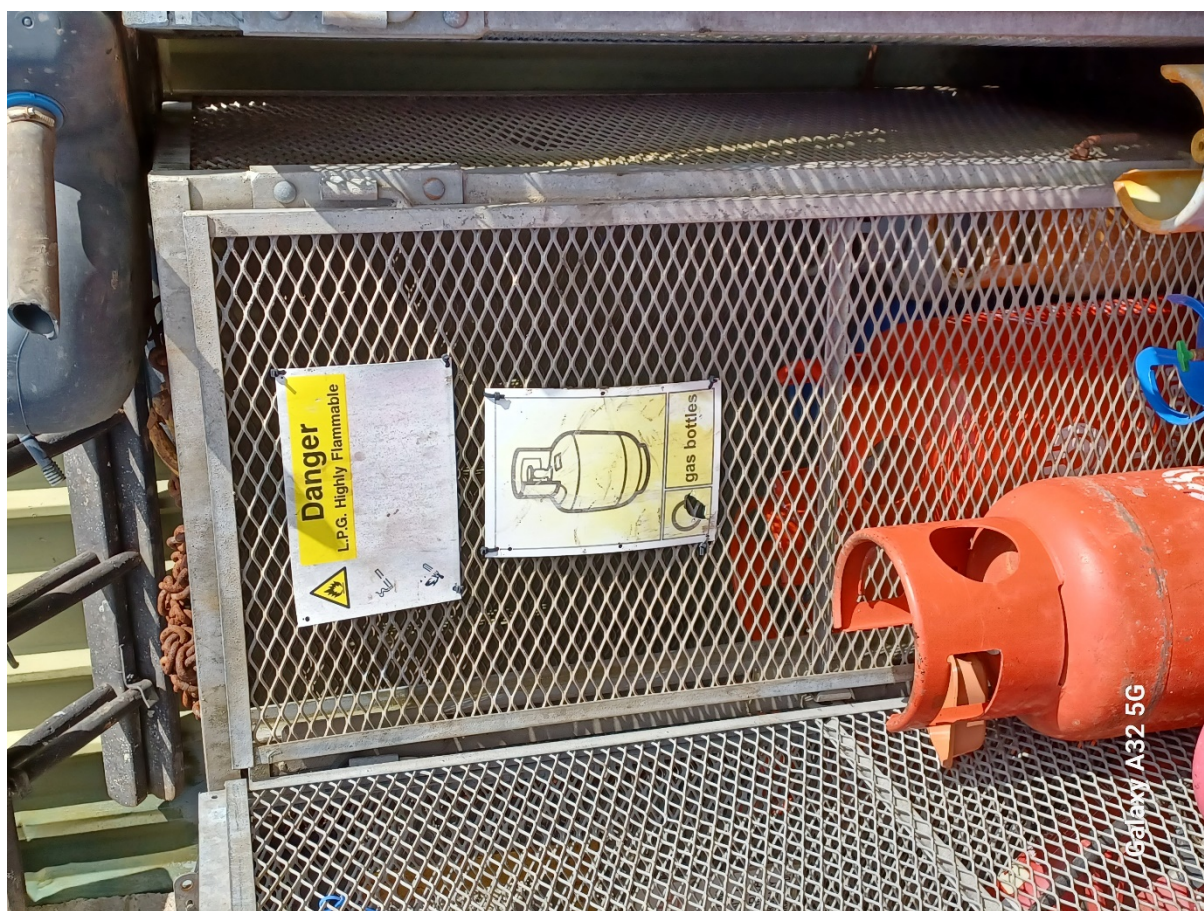
The site's Technically Competent Manager visits the site regularly and holds an up-to-date WAMITAB certification that expires in July 2027.

W2C- Operating Techniques

Permit Condition 5.3.1 states: *All wastes received, inspected, accepted or rejected, and recorded in accordance with the standards specified in Table 5.3.*

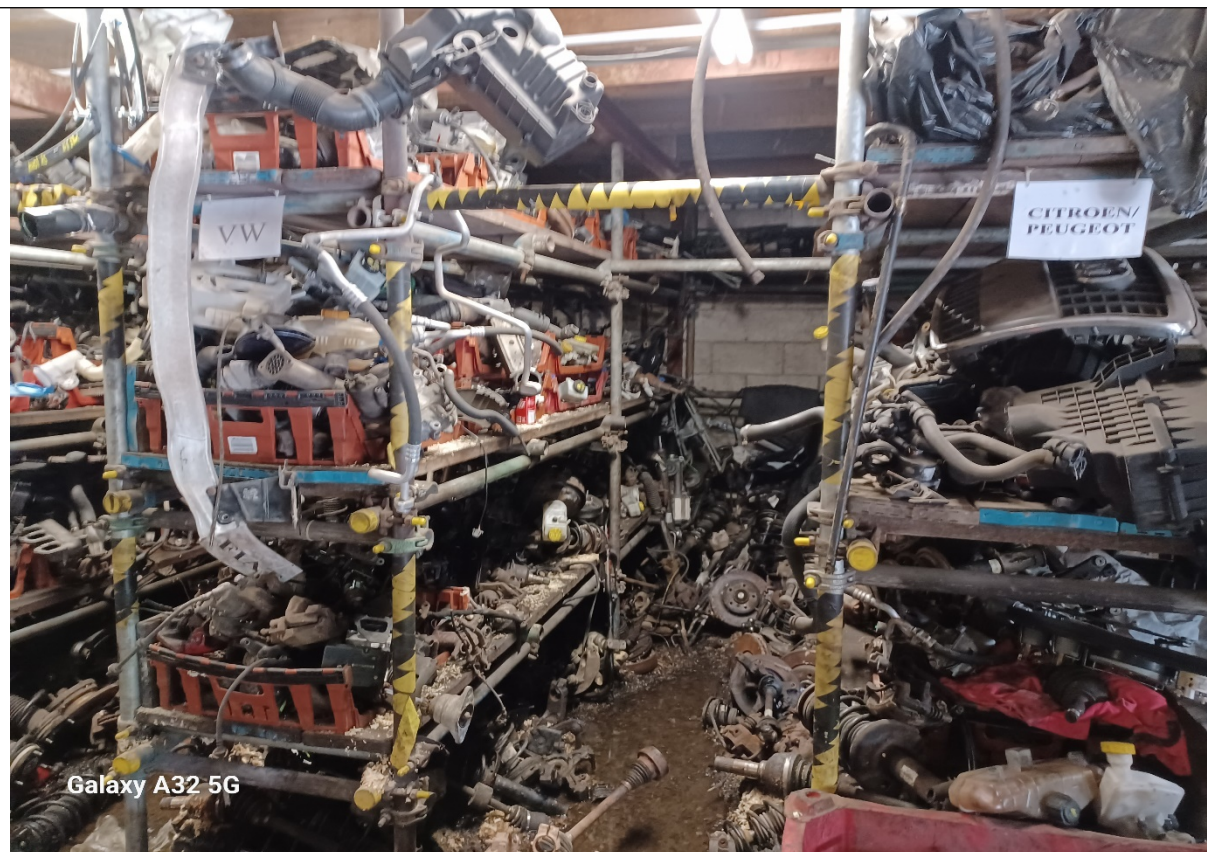
The site accepts a number of waste codes. All waste was correctly segregated. There was no evidence of mixed/contaminated waste within any of the waste storage areas or containers.

W2E-Waste Acceptance

Permit Condition 6.1.1 states: *A summary of the waste types and quantities accepted and the waste types and quantities removed from the site shall be made for each financial year and shall be submitted to the Agency within 1 month following the end of that year.*

The site accepts a number of waste codes. Annual returns have been received on time. The annual returns have been checked against the sites waste codes and are correct.

W2F- Technical Requirements

Permit Condition Table 5.4 a ii states: *End of life vehicle fluids shall only be stored in areas provided with an impermeable pavement and a sealed drainage system provided in accordance with condition 3.1 at the location marked on the site plan referenced JAB01/02.*

During the site inspection, the self-contained ELV depollution area was looked at. The operator uses very modern methods to extract all fuels, oils and liquids from ELV vehicles and disposes of the wastes from these vehicles correctly. In the event of any hydrocarbon pollutants leaking, the operator has a good spill policy and spill equipment in place to mitigate this.
