4. Details of our assessment

Visit comments

On 28th August 2025, Officer C RHODES met with Maintenance Technicians at **St Fagans National Museum of Wales** for a routine inspection of the package treatment plant referred to in permit **NP3327XE**. Weather at the time of inspection was intermittent rain showers following a period of prolonged dry weather.

During this visit, several assets were inspected – see CAR_NRW0049258 in conjunction.

Package treatment plant

The package treatment plant (PTP) is located at the base of the site and serves the hut/office at the entrance to the car park of the site. Upon lifting the tank cover, there was a significant build-up of sludge visible at the edges and a plentiful mosquito population. Technicians said it had been tankered fairly recently, but Officer RHODES suggested to do this again and consider reviewing the frequency if necessary – see Actions.



Process bacteria on the rotating arms of the plant also appeared to be two different colours, though this could be for a number of reasons and does not necessarily relate to treatment. Effluent within the tank appeared to be slightly discoloured but the outfall inspection did not raise any causes for concern.

The sample point marked on Schedule 7 of the permit was not identified during the visit and therefore a

representative sample was not taken – see Action 3.

Discharge point

Following the site walkover, the discharge point was accessible via a public footpath. The outfall was discharging at the time what appeared to be storm water; there was some growth visible but no discolouration associated with sewage or odour observed and no visible impact on the receiving watercourse, in this case the River Ely. Summary

In conclusion, the site was found to be compliant with its permit at present, however this determination may change pending further information. As detailed in CAR_NRW0049258, whilst there was no observed evidence of non-compliance with emissions to water, the inspection raised concerns with the understanding of plant operation and maintenance requirements.
