4. Details of our assessment

Celtic Recycling Limited Site Visit, Bridgend (UB3998FB) – 21/08/2025

Waste Regulation Officer Gareth Morris accompanied by Waste Regulation Officer; Dan Hopkin and Enforcement Officer; Clive Walker visited Celtic Recycling Limited, Unit 37, Village Farm Industrial Estate, Pyle, Bridgend, West Glamorgan, CF33 6BZ on; 21/08/2025 to conduct a routine site inspection and to assess compliance with environmental permit; UB3998FB).

The operator holds a: Tier Three (3) bespoke permit for a hazardous and non-hazardous mixed metal waste treatment facility.

On arrival at site, we were met by the site supervisor who kindly showed us around the site.

Weather on day of inspection, was clear, dry with little wind.

Breaches Recorded

W1A- General Management

Route Cause Breach 1.1.1

Permit Condition 1.1.1 (A) states: *The operator shall manage and operate the activities:*

- a. *In accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure, and those drawn to the attention of the operator as a result of complaints.*

Permit Condition 1.1.2 states: *Records demonstrating compliance with rule 1.1.1 shall be maintained.*

During my inspection of the site, I asked for access to the permitted site's environmental management system (EMS) and all other paperwork relating the permitted site.

Action: I informed the permit holder that it was vital that the site permit, environmental management system and other associated documentation is always available. As the permit holder had breached this permit condition, I informed them that they would receive a Category Three (3) breach for this breach of permit condition.

Areas assessed as compliant and other comments can be found below.

W1A- General Management

Permit Condition 1.1.4 states: *The operator shall comply with the requirements of an approved competence scheme.*

The site's Technically Competent Manager visits the site regularly and holds an up-to-date WAMITAB certification that expires in 2026.

Permit Condition 2.2.1 states: *The activities shall not extend beyond the site, being the land shown edged in green on the site plan at schedule 7 (seven) to this permit.*

All of the operator's permitted activities were carried out within the permitted. There was no evidence of any debris leaving the permitted area.

W2C- Operating Techniques

Permit Condition 2.3.2 states: Wastes shall only be accepted if:

- A. It is of a type and quantity listed in schedule 2 table(s) S2.1 (S2.2 etc.); and
- B. It conforms to the description in the documentation supplied by the producer and holder.

The site accepts a number of waste codes. All waste was correctly segregated. There was no evidence of mixed/contaminated waste within any of the waste storage areas or containers

W2E-Waste Acceptance

Permit Condition 4.2.2 states: *Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.*

The site accepts a number of waste codes. Quarterly returns have been received on time. The quarterly returns have been checked against the sites waste codes and are correct.

W2F- Technical Requirements

Permit Condition Table S1.1 states: *Sealed drainage for all external areas of the site used to store and/or treat waste shall comprise of a lawful discharge to surface water via a suitable interceptor.*

At the time of inspection, all drains and gulley channels were clear of any debris and the interceptor was clear and in good working order. The sites interceptor was last emptied in March 2025.

Permit Condition 2.4.7 states: ***Hazardous waste shall not be mixed, either with a different category of hazardous waste or with other waste, substances or materials, unless it is authorised by schedule 1 Table S1.1 and appropriate measures are taken.***

During the site inspection, officers were shown how the hazardous waste area of the site operates. Site operatives explained to officers how capacitors containing Polychlorinated biphenyls (PCB) were treated and stored. The hazardous waste area is well contained, and all hazardous waste operations are undertaken behind a bunded wall to ensure any pollutants in that area are fully captured and contained.
