4. Details of our assessment

National Grid (EPR-AB3392ZY) – 14/08/2025

Waste Regulation Officer Daniel Hopkin attended the permitted facility of National Grid Electricity Distribution (South Wales) PLC at Tremains Road, Bridgend, CF31 1TZ on the 14th of August 2025 to undertake an unannounced routine site inspection.

National Grid Electricity Distribution Bridgend hold a Standard Rules 2012 No15, Storage of electrical insulating oils permit for this site.

I arrived at approximately 10:00am. The weather was overcast with rain.

Infrastructure and Storage

The site infrastructure was in good condition throughout, with no signs of damage to the impermeable surface and drainage. The site had good security measures in place, with cameras and electric gates.

All waste oils were stored on an impermeable surface in a concrete bunded area in accordance with permit condition 2.3.1. There were spill kits available throughout on site.

Environmental Management System (EMS)

A copy of the Environmental Management System (EMS) was available on site to see in line with permit condition 1.1.1(a).
