4. Details of our assessment

Environment Officer Peter Jones attended the site on 23 September 2025 and met with the site manager.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the people/property/environment
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

Site Report

The inspection involved a visual review of the site infrastructure and drainage and a review of documents required under the permit conditions. Overall the site infrastructure was found to be in good condition. There are areas of the concrete hard standing which are beginning to break up and these will need to be repaired. Please ensure repair works are completed within a reasonable time frame.

Overall, the site was clean and tidy and there were no reports of noise or odour complaints.

Following the site inspection, the officer proceeded to the site office to inspect documents required under the permit conditions, these were all in order and available for inspection.

Carcases are currently removed by Celtic Baits and waste transfer notes were available for inspection.

The site management plan and incident procedures had recently been reviewed and training records were found to be up to date.
