4. Details of our assessment

This compliance assessment is in relation to incident WIRS 2508455 for Weycock Cross SPS.

On the 12th of September DCWW issued a self report to NRW regarding pump failures at Weycock Cross SPS leading the site to spill under emergency conditions. It was said this was due to "An electrical issue in the background behind the pump's operation. An issue with the software that controls the drives that allow for the pumps to be called in".

The site appeared to spill for approximately 8 hours on 12/09/25 and another 8 hours on 13/09/25. This occurred during a period of heavy rainfall. Tankers were said to have been used to try and manage the flows. Samples were also taken, however due to access the outfall was not able to be observed. The results are as follows:

Downstream pictures of the watercourse were also taken, showing no visual impact.

This incident will be classed as no impact, the site spilled under emergency conditions and during heavy rainfall. The discharge was dilute and into a spate watercourse with no signs of visual or water quality impact.
