4. Details of our assessment

CILGWYN LANDFILL – SITE INSPECTION GAS INFRASTRUCTURE

Following on from the landfill gas emissions assessment report required by the permit and closure plan, the site was inspected to assess the works completed by Egniol, Cyngor Gwynedd's chosen consultant.

GAS COMPOUND/FLARE

Flare assessment and performance showed that the flare was operating at >1000 DegC. This is the ideal combustion temperature to promote the complete oxidation of methane the main greenhouse gas produced from the site. There were no more points of note in the gas compound and all plant is operating in full compliance.

GAS EXTRACTION FIELD

Infrastructure identified in Egniol's surface emissions report, was assessed and found to be in compliance with Permit/Closure Report specifications.

Note: Please check well heads and pipe connectors for strain and bending following temperature fluctuations and insert pipe extensions to ensure no gas leakage through the boot detail.
