4. Details of our assessment

This report details the site visit made on the 17th September 2025 to United Recycling Aggregates LTD, permit reference number EPR-PB3230AQ. Officers Carla CURTIS and Nicola ROSSITER attended the United Recycling Aggregates LTD site at Birdport Docks, Newport, NP19 4RE for a routine site inspection at 12:15. On arrival the gates were locked and the site appeared non-operational. A visual inspection was made through the gates. The weather was mild, windy with light rain.

GENERAL OBSERVATIONS

The site was primarily used as a storage area for small amounts of waste material such as aggregates. At the time of the visit the site was empty and appeared non-operational (see photo 1). General housekeeping on the site was of a good standard, the infrastructure on site appeared adequate with no cause for concern.

After the site visit, I rang and spoke to the site supervisor, who advised that the permit is in the process of being transferred over to another company, so the site is not currently being used.
