Site visit:

An inspection of Taff Merthyr Colliery and Minewater Remediation Scheme was carried out for to check compliance with permits AN0319501 (discharge 1, Upper) and AN0350601 (discharge 2, lower), and water resources abstraction licence WA0570021001. During the visit, the weather was mild and dry.

Environment officers from Natural Resources Wales (NRW) were accompanied by the operational manager for the site from the Mining Remediation Authority (MRA).

Abstraction records were requested verbally on site, and via email on the 08/09/25.

Submit annual abstraction rates by 16/10/25.
