PERMIT INSPECTION

On Wednesday 17th September 2025 NRW Officers Nicola ROSSITER and Carla CURTIS attend the facility at 10.30am for an un-announced routine inspection of permit number EPR/AB3596FZ held by Environmental Waste Services Ltd. The weather was raining on and off with some wind at the time of inspection. Officers ROSSITER and CURTIS walked around the site before being greeted by Operator; Mark Selway.

The site was in good order and had no waste stored outside of specified containers. At the time of the inspection the site had an enclosed roll on roll off skip bin (photo 1) as well as a smaller enclosed skip (photo 2). Mr Selway advised all material is bagged and wrapped individually which is then stored within the enclosed skips which appears to be well maintained and locked. The site security was secure with lockable gates, a tall metal fence surrounding the yard and cameras on the office and bin areas.

No offensive noises or odours were witnessed by either Officer while on site. No concerns or actions were raised and Officers Rossiter and Curtis left site at 10.55am.
