4. Details of our assessment

Natural Resources Wales officer Shaun Rees met with Mr & Mrs Jones and Will Lea to carry out a routine audit of the site on the 29 September 2025 at 10:15.

You will be happy to hear that no non compliances were identified on our visit.

During the audit, we discussed the possible changes to the permit, regarding a name change and the potential to increase bird numbers. These changes will have to be done

separately with a full transfer to change the name from a sole operator to the farm business name at a cost of £2,761 and a variation to increase the bird numbers on site at a cost of £6,192 . Please see below, the links to assist you in these applications including a link to the charging scheme.
